First Notice . . .

Members to Vote On Constitution and By-Laws Amendments At Regular Meeting of March 14

Pursuant to Article XVI, "Amendments," of the By-Laws of the Overland Park Host Lions Club, the Board of Directors hereby submits certain amendments for a vote by the membership at the regular Club meeting on March 14.

Amendments to be considered include all or parts of the following By-Laws: **Article VII: Officers:** (number of vice presidents); **Article VIII: Board of Directors: Sections A and G** (size of board and election of directors); and **Article X: Vacancies** (procedures for filling).

The text of the amendments is on Page 2 of this issue of the *Lions' Roar*.



The amending process is provided by Article XVI, Sections A and B, which state, "These By-Laws may be amended at any regular or special meeting of this Club at which a quorum is present, by the affirmative vote of two-thirds (2/3) of the members present in person and voting, provided the Board has previously considered the merits of the amendments"

and that "No amendment shall be put to vote, unless written notice thereof, stating the proposed amendment, shall have been mailed or delivered personally to each member of this Club at least two (2) weeks prior to the meeting at which the vote on the proposed amendment is to be taken."

The Board "considered the merits of the amendments" at its regular monthly meeting on Saturday, February 7, 2009. This newsletter, distributed by electronic mail and/or through the United States Postal Service meets the requirement of two weeks' advance written notice.

The affected Articles and Sections on the next page are copied as they currently apply. Changes effected by the proposed amendments are shown in the text as follows:

Deletions are shown by "double strikethroughs," as in this example: "double strikethroughs."

Changes in text or additions are shown in bold-face type, as in this example: **bold-face type**.

If the amendments are approved on March 14, they will take effect immediately and the Nominating Committee will proceed to solicit candidates based on the new Vice President and Board structure.

The **Nominating Committee** (Past President Mae Claxton, chair) will submit a slate of nominees to the membership on March 28 and April 11. The slate of nominees will also be published in the April issue of the *Lions' Roar*.

Election of officers for 2009-2010 will be held by written secret ballot at the regular meeting of April 11.

Board of Directors Notes

Meeting of February 7 (unofficial notes): (1) Minutes of January 3 meeting and Treasurer's reports for January accepted. (2) Wyndham Garden hotel contract covering meal cost and room reservations through December 2009 approved. (3) Special membership-recruitment program for February 28 discussed. (4) Discussed possible participation in Overland Park "Mardi Gras" days, June 5 and 6, 2009. Decision delayed. (5) Neal Nichols will serve as interim Host Committee chairman for the 2013 USA/Canada Forum to be held in Overland Park per request of Past International Director Ed McCormick. (6) Consideration was given to several amendments to Club Constitution and By-Laws. Those regarding number of vice presidents and directors, and related election-procedure sections were approved for submission to the Club for vote on March 14. Others were tabled until the March 7 Board of Directors meeting. See full text of amendments including deletions, additions, and changes in the next column.



PROPOSED AMENDMENTS

(See explanatory article on Page 1.)

ARTICLE VII Officers

Section D. DUTIES.

(3) VICE-PRESIDENTS: There shall be three (2) two (2) Vice-Presidents; a 1st Vice-President; and a 2nd Vice-President and a 3rd Vice-President. If the president is unable to perform the duties of his/her office for any reason, the vice president next in rank shall occupy his/her position and perform his/her duties with the same authority as the president.

If, prior to the first election following the adoption of this Section, there is any vacancy in the position of a Vice President who has years remaining on his/her term, the Nominating Committee shall not act to fill such vacancy, provided however that a minimum of two (2) Vice Presidents is ensured for the next year. At the second and each subsequent election following the adoption of this Section, one (1) Vice President shall be elected.

Each vice president shall, under the direction of the president, oversee the functioning of such committees of this Club as the president shall designate.

ARTICLE VIII Board of Directors

Section A. The members of the Board of Directors shall be the president, immediate past president, the three (3) two (2) vice presidents, secretary, treasurer, Lion tamer, tail twister, membership director and six (6) four (4) elected directors.

Section G. One third (1/3) half (1/2) of the directors shall be elected annually and shall take office on the July 1st next following their election, and shall hold office for three (3) two (2) years from that time, or until their successors shall have been elected and qualified., with the exception that at the first election held after the adoption of this Constitution and By Laws, one third (1/3) of the directors shall be elected for three (3) year terms, one-third (1/3) of the directors shall be elected for two (2) year terms and the other one third (1/3) of the directors shall be elected for one year terms.

Nothing in this Section shall be construed as requiring directors elected in the two years prior to its adoption to resign or be removed from their respective positions.

If, prior to the first election following the adoption of this Section, there is any vacancy in the position of a Director who has one or more years remaining on his/her term, the Board of Directors may at its discretion advise the Nominating Committee not to act to fill such vacancy, provided however that a minimum of four (4) directors is ensured for the next year.

ARTICLE X Vacancies

Section A. If the office of president or of any first vice president shall become vacant for any reason, the vice presidents next in rank shall advance in office. **according to their rank*. In the event such provision for advancement shall fail to fill the office of president, or first or second vice president, the Board of Directors shall thereon call a special election, giving each member in good standing prior two (2) weeks notice of the time and place thereof, which time and place shall be determined by said Board, and such office shall be filled at said election meeting.

In the event of a vacancy in the office of third second vice president, the Board of Directors may appoint a member to fill the unexpired term.
